4. FIRST AID MEASURES

EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lens, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice if symptoms persist.

SKIN: Remove contaminated clothing and wash before reuse. Rinse skin with plenty of water for 15-20 minutes. If skin irritation occurs, seek medical attention. Call a poison control center or doctor for treatment advice.

5. FIRE FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

SPILL AND LEAK RESPONSE: Uncontrolled releases should be responded to by trained personnel using pre-planned procedures. Proper protective equipment should be used. In case of a spill, clear the affected area, protect people, and respond with trained personnel.

PERSONAL PROTECTIVE EQUIPMENT: The proper personal protective equipment for incidental releases (such as 1 liter of product released in a well ventilated area), use impermeable gloves, goggles, face shield, and appropriate body protection. In the event of a large release, use impermeable gloves, chemically resistant suit and boots, and hard hat. Self-Contained Breathing Apparatus or respirator may be required where engineering controls are not adequate or conditions for potential exposure exist. When respirators are required, select NIOSH/MSHA approved based on actual or potential airborne concentrations in accordance with the latest OSHA and/or ANSI recommendations.

ENVIRONMENTAL PRECAUTIONS: Stop spill at source. Construct temporary dikes of dirt, sand, or appropriate readily available material to prevent spreading of material. Close cap or valves and/or block or plug hole in leaking container and transfer to another container. 7. HANDLING AND STORAGE
